# **DRESS CODE**

# WHEN PLAYING ON THE COURSE

- Smart golf wear must be worn.
- Shirts must have collars and sleeves (small sleeves acceptable).
- All shirts must be tucked in, unless purposefully designed to be worn outside.
- Shirts worn outside should be no longer than 3 inches below the belt /waist.
- Tailored shorts or trousers must be worn tailored means with belt loops and fly, no baggy pockets.
- Long socks or short golf/sports socks are acceptable
- Golf shoes must be worn. (caddies or non-playing guests may wear trainers on the course)

#### NOT ACCEPTABLE WHEN PLAYING ON THE COURSE

- Tracksuits
- Fatigue style trousers
- Rugby or Football shirts
- Sports shorts
- T-Shirts
- Beach shorts
- Denim trousers or denim NON GOLF logos shorts
- · Trainers or Flat Soled Shoes
- Please do not tuck trousers into socks
- Please do not roll down long socks if worn with shorts

#### IN THE CLUBHOUSE

- At all times the dress standard shall be smart golf wear or SMART casual attire unless otherwise stipulated
- Plain trousers of smart denim and of uniform colour are acceptable
   No fraying, slits or metal attachments
- Dress rules for Social Occasions will be advised by the organiser(s)
- Footwear must be worn in the Clubhouse
- Golf shoes should not be worn in the bar or restaurant areas of the Clubhouse

#### NOT ACCEPTABLE IN THE CLUBHOUSE

- Trainers
- Tracksuits
- Head wear
- Waterproofs
- Beach shoes or Crocs
- Wet or soiled clothing

The dress code does not apply to children under 12 years of age.

## MOBILE TELEPHONES

Mobile telephones taken onto the golf course must be switched off and only used in cases of genuine emergency

## **COURSE RULES**

- The Club Captain, Ladies' Captain and President of the Club have precedence on the tee at all times.
- All play must commence from either the 1st or 10th tee unless otherwise authorised.
- All Inter-Club Matches have some form of Tee Reservation and have priority on the course. All Knock Out Cup Matches have priority on the course. If either Club Matches or K.O. Cup Matches are being held up, they must be allowed through.
- Filtering In. Players waiting to start their round must allow one match
  on, or near the green immediately preceding their starting tee to
  continue before they themselves commence play. After one match is let
  through it is the turn of the first match waiting to tee off. This continues
  alternately, a queue of waiting players cannot block a tee. This rule will
  not apply when Competition Reserved Times are in force.
- Queuing at Tees When there is a queue waiting to commence play at
  any tee, a match must be fully made up before it can take its place in the
  queue. For example, a two-ball cannot get to the front of the queue
  and then invite a third player to join them. This has been a recognised
  point of etiquette at Louth Golf Club for some time and was recently
  reaffirmed by the General Committee.
- The use of White Markers is reserved for Club Matches, Club Competitions, K.O. Cups, County, National and Professional Events only, All other play must be from the yellow, red or blue tee markers.
- The Ground staff MUST be given priority wherever they are working on the course. DO NOT PLAY if there is a risk of hitting them. Wait until they stand aside and give you the all clear.
- Members shall at all times replace divots, repair pitch marks and rake bunkers after use.
- Only singles, two-ball, three-ball and four-ball play is permitted on the course.
- Practicing on the course IS NOT ALLOWED.
- Pre-Junior members being persons up to and including the age of 10
  years. Such Pre-Junior members may only play golf on the course under
  the direct supervision of an adult Member of the club.
- Any person who submits a request to the Committee to place any
  form of memorial/commemorative plaque on the golf course for any
  reason whatsoever must do so with full details of size, form, colour,
  text, mounting and proposed location and such submission must be
  approved by the members at a General Meeting.
- Insurance Members are reminded that it is their individual responsibility to insure their personal property, including golf clubs, against loss by theft or otherwise. This includes property stored in lockers. All property stored on Club premises is done so at the risk of the owners of the property.
